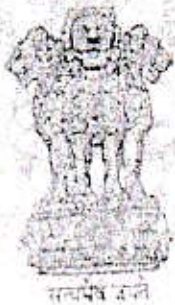

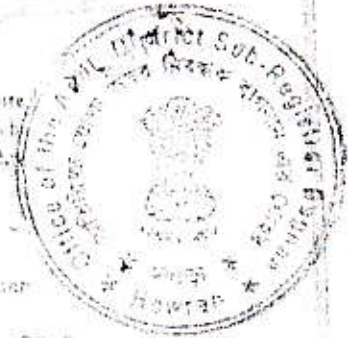

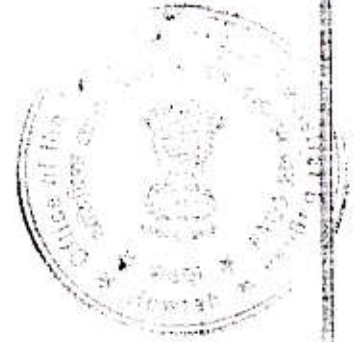

The Board of Trustees shall have right to shift the office to any other place in this District or open local office or offices at place deemed necessary.

2. **Interpretation :-**

a) Trust means the Trust created by this Deed i.e.

Bagnan Educational and Welfare Trust.

b) The Board shall mean the board of Trustees created by this Deed.

- c) **Trust Property** shall include every kind of property moveable and immovable owned by the Trust and mentioned in the books of account and in other documents in the possession/ custody and control or that ought to be in the possession, custody and control of the Trust.
3. **Aims and Objects** : The aims and objects for which the Trust established are as follows :-
- a) To promote the Educational, Social and Cultural upliftment and General Welfare of the people.
- b) To establish and run Cultural and Educational Institutions for boys and girls.
- c) To take over, establish, acquire, start, run, maintain or manage (Higher) educational institution (M.Ed., B. Ed., D. Ed. College, Junior Basic Training College, Engineering College etc.) Nûrsery Schools, Primary School and Madrasahs, Libraries, Hostels, Reading Rooms, Study Centres, Orphanages, Vocational Training Centres, Crafts Training and Production Centres, Computer Training Centres for the promotion of Higher education and vocational skill among the backward people.

- d) To start, set up, take over, acquire, run, maintain or manage Agricultural Training Centres and Firms, Fishery and Poultry Training Centres, Fruits Processing Training Centres for the economic and social upliftment of the people.
- e) To work for the maintain is peace, harmony and Human Rights through Literatures, Handbills and Booklets.
- f) To conduct and organize, seminars, symposiums, getogether Public meeting for creating and developing communal Harmony, Peace and to eradicate and abolish communal hatred and ill feeling among the people.
- g) To observe the birth day of prophet and to organize seminars for the promotion of moral values in the day to day life.
- h) To impart education with up-to-date knowledge of latest developments within all fields of human activities and to make original contributions to the refinements, enhancements and increase of such knowledge, application of the same to the moral, material and spiritual progress of human being.
- i) To establish, furnish, and help in establishing and furnishing libraries, study centre, reading rooms for the promotion of general knowledge as well as Islamic.

4. Raising of fund and expenditure :-

For achieving any or all objects of the Trust the Trustees can collect or raise funds through donations, grants and contributions and to obtain and receive loans from individuals, associations, firms, bank or any Institution maintaining land and order whatever and to invest and deal with the money and funds belonging to the Trust not immediately required in such manner as may from time to time be determined by the Board of Trustees subject to the law of the land and to take on lease other property both moveable and immovable and shall also receive grants and donations from Foreign Governments, Institutions or Agencies and Individuals according to the prevailing law of the land. AND to remunerate any person, firm or institution for service rendered to the Trust in any capacity and to pay out of the funds of the Trust all costs, charges, expenses incidental to the establishment, registration and advertisement of this Trust and to adopt and take conductive to the accomplishments of all or or any of the above objects.

The incomes and properties of the Trust whatsoever derived or obtained shall be applied solely towards the promotion of the objects of the Trust and no portion thereof shall be paid to or divided amongst any of its members by way of profits.

6. **Meeting & Quorum :-**

a) The Trustees may from time to time frame rules for conducting. However, in the absence of such rules and regulations the meeting of the board shall be held at least once in a half year or earlier on the requisition of at least 1/2 of the Trustees to consider the affair of the Trust and all the proceedings of the meeting shall be recorded in the minute book by the General Secretary of the Board. Notice of meeting should be served at least four days in advance unless some emergency need to violate such rule.

b) In the event of any decision required to be taken on an emergent purpose, at least 50% of the trustees should be informed and of course however, subject to the rectifications of such decisions by the other trustees at the earliest.

c) The president of the Board should preside over every meeting and in the absence the General Secretary shall do such job.

d) The Quorum of the meeting shall call for the presence of at least 4 members of the Board of Trustees.

g) Resolution passed without any meeting shall be valid and effect only when the same is approved by the trustees in writing showing an evidence of their clear consent in favour of the resolution without any condition or clause super imposed therein.

7. Vacancies :-

A. Vacancy shall arise among the Trustees in the following cases :

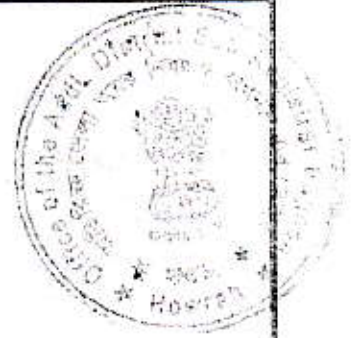
- When the Trustee dies.

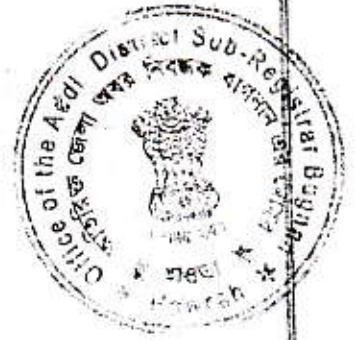

- (\*) To acquire moveable and immovable property/ies by purchase or otherwise.
- (\*) To erect buildings/equipment/machineries for the use, benefit and attachment of the object of the Trust.
- (\*) To sell, transfer, alienate, exchange and mortgage movable and immovable properties belonging to the trust. This has to be approved by the valid quorum of the Trustees in a meeting and a resolution passed to that effect. The sale deed shall be signed by the President and General Secretary.
- (\*) To manage, administer and control properties and all assets of the Trust/Institution/s directly or indirectly under its control or connected with the Trust.
- (\*) To demand, call for and realise money and other assets due or belonging to the trust and issue receipts and vouchers for the same.
- (\*) To employ or appoint staff/officials for the management and administration and running of the trust in general and for the institutions in particulars
- (\*) To enter into contract/s borrow or lend money for the purpose of the Trust and management of the properties and affairs.

- (\*) To suspend, terminate and dismiss any staff/teachers/officials under their control including clerks, accountants, officers etc.

- (\*) To make, vary, alter, modify, change scheme(s) rules and regulations that may be needed to protect the interest of the Trust or institution and for the furtherance of their causes or institution and for the furtherance of their causes or giving effects to the object of the Trust and institution.

10. **Function of the Office Bearers :-**

A. **President :**

- i) The president will be elected by the majority of the Members (Trustees) present in the meeting convened for that purpose.
- ii) The president will preside over the meetings of the Trust and conduct the proceedings.
- iii) The president in his own discretion or by the request of one-third of existing members can call for a meeting of the Trustees.
- iv) The President is empowered to delegate such powers to the General Secretary of the Trust.

B. **Vice- President :**

The Acting President shall assist the President in all affairs of the Trust. In absence of the President and on request, he shall have the powers and to perform duties of the President.

C. General Secretary :

The General Secretary of the Board of Trustees, elected under control and supervision of the Board, shall conduct and manage all the affairs of the Trust, its properties and institutions, sign papers and carry on the correspondence on behalf of the Trust and shall be responsible for the safe custody of records of the Trust and the keeping of proper accounts thereof. He shall also perform such other duties as may be entrusted to him from time to time by the Board provided that in the absence of the General Secretary of any other Trustee specially authorised on that behalf of the Trust and do all or any of the duties relating to the General Secretary under the clause. The General Secretary shall attend to the correspondence and day to day affairs of the Trust. The Secretary expenditure from and out of the funds of the Trust subject to a maximum of Rs. 1,000/- (Rupees One Thousand) only and anything in excess of Rs. 1,000/- (Rupees One Thousand) only is to be incurred with the sanction of the Board. He shall have the custody of the correspondence and other books relating to the General Secretary under the clause. The General Secretary shall attend to the correspondence and day to day affairs of the trust.

D. **Assistant Secretary :**

The Assistant Secretary shall assist the General Secretary in all affairs of the Trust. In absence of the General Secretary and on request, he shall have the powers and to perform duties of the General Secretary.

E. **Treasurer :**

The treasurer shall collect and receive all sorts of the subscriptions, donations and deposit of money and grant receipts of money thereof. He will maintain and keep cash book and such other accounts as are necessary.

F. **Fund / Capital :**

At present Rs. 10,000/- (Rupees Ten Thousand) only.

11. **Bank Account :-**

The Bank Account shall be operated jointly by any two of the following :-

12. **Suits and Legal Proceedings :**

The board of Trustees may sue or to be sued in the named of the General Secretary subject to a resolution passed specifically for this purpose. The board may authorise any of the office bearers by a Power of Attorney or otherwise to represent the Board of Trustees in the following.

13. **Official Year :**

The official year of the Trust shall be 1st April, to 31st March of each year. This can be changed by the Board of Trustees duly approved in a meeting.

14. **Winding up the Trust :**

The Trustee shall have the power to wind-up the activities if they find that the purpose for which the Trust was created could not be accomplished despite all efforts by the concerned Trustees. However, this should be approved by at least three-fourth of the existing Trustees in a meeting wherein the presence of all the members shall be needed. Income and property should be utilised for the repayment of the debts of the trust .

It is expressly declared that no part of the Trust property or income shall be applied for any purpose other than educational one

This trust and the Rules set forth under this indenture shall come into force immediately after the execution and registration thereof.

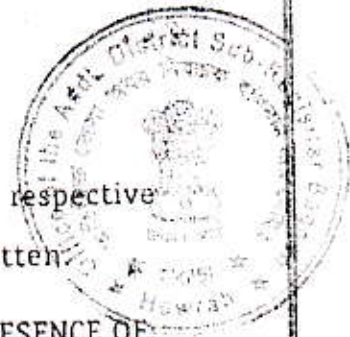
